President's Report

During the last fiscal year a permanent bridge and approaches have been constructed at Kelley's Cove, leaving only one permanent structure of the same type remaining to be completed within the Village area.

Mrs. Sarah G. Blaisdell, widow of Philo C. Blaisdell, for many years one of the Village Overseers, has presented to the Village Corporation a parcel of land on Bay and Sea Streets, to be known as "PHILO BLAISDELL PARK" and to be used as a public common under such rules as the Corporation may make from time to time. This gift has been accepted by the Corporation.

Mr. Bennett S. Ferguson has offered to present to the Village the building known as the "Bayside Theatre," to be used by it as a Town Hall, and, also, to be used as a Casino for the presentation of moving pictures and such other types of amusement as may be thought desirable from time to time. The question of the acceptance of this gift will be presented to the voters at the annual meeting for their decision.

The Village finances are in good order, all bills contracted for having been paid, with a reasonable surplus remaining in the treasury.
