# NVC Utilities Committee Trustee Meeting Community Hall and by Zoom link Friday, October 6, 2023, 1:00 p.m.

The October meeting of the NVC Utilities Trustees convened at 1:03. Utilities chair, Jeffrey Wilt called the meeting to order.

#### **Community Member Comments:**

Rachel Rossa asked a clarification on some points reflected in the September meeting minutes

#### **Approval of minutes:**

<u>David moved (Judy second) approval of minutes of September 8, 2023, minutes. The motion was unanimously adopted.</u>

#### **Superintendent Report:**

- Pumping out tanks due to August & September BOD (biological oxygen demand) exceedances.
- Numbers are much higher than normal untreated wastewater. Organic waste going out is strong than should be coming in.
- System made for human waste and toilet paper and that is it. Look for unusual occurrences home brew, commercial baking, etc. Send e-mail blast remanding people what can go in system. Also use Village Website, Dan's website, invoices in November.
- System is not made to treat soluble BOD paint, grease, etc..
- No known commercial users in Village.
- Large number of contractors—paint in system.
- Numbers are much higher than normal untreated wastewater. Organic waste going out is strong than should be coming in.
- What is the consequence of people misusing the system? They could be fined.

#### October 8, 2023, Minutes

- Rainy summer, Village is full
- Rent portable samplers to track BOD concentration at different points
- TSS is level. What soluble BOD is coming in untreated? Wastewater system does not make soluble BOD.
- Chuck has been talking to our DEP inspector. Show state we are jumping on this but do not understand source of soluble BOD.
- One option is the addition of a "mixer" in our tanks to further break-down organics. Include in next year's budget
- The Tank holding sodium hypochlorite is leaking. Leak of approximately 2 gallons of sodium hypo. Tank is being emptied.
- Is it the correct tank? Look at condition of tank when it is empty.
- Big "thank-you" to Fernie for assistance in clean-up

#### Moratorium

- Our efforts to control BOD exceedances us of all three trains, cleaning out tanks have not created stability in our system. Numbers are worse than when we started.
- We are reminded that a Moratorium is not permanent, it buys us more time.
- A six-month extension would extend the moratorium to mid-April.

Judy Metcalf presented a motion to expand the moratorium that prohibits permits to be processed or approved for new connections to the sewer system for the period of October 6, 2023 to April 6, 2023. Motion was seconded by Brady Brim-Deforest. The motion was adopted with yes votes from David Crofoot, Judy Metcalf, Jeffrey Wilt, Brady Brim-Deforest

#### **Water Department**

- Belfast Water District will increase water rates by 30% on January 1, 2024.
- Rates have not changed for 9 years.

#### **Contract with Water Quality Maine (Chuck Applebee)**

Our contract with WQM will automatically renew January 7, 2024 as it is a re-occurring contract with 60 day notice.

- Jeffrey reminded the Trustees that in, January 2023, when we entered into the WQM contract we planned to issue an RFP before renewing contract.
- The Trustees discussed the fact that the RFP commitment when made when Chuck was an unknown.
- RFP's cost \$ and take time. Should we invest \$ in RFP when we have real satisfaction.
- Brady reminded the trustees that he made over 70 calls/emails in 2022 to assess our options for system management—two firms responded—WQM and a much larger firm which recommended WQM.

Judy Metcalf presented a motion to not proceed with an RFP and allow our WQM contract to renew for 2024. Motion was seconded by Brady Brim-Deforest. The motion was adopted with yes votes from David Crofoot, Judy Metcalf, Jeffrey Wilt, Brady Brim-Deforest

The Trustees reviewed a draft sewer system budget for 2024.

### **Drinking Water Department**

September 2023 Production and Water Quality.

Purchased water for the month averaged 42,760 gpd compared to 47,648 gpd for the same month in 2022. The weekly free chlorine residual in the drinking water ranged from 0.05 - 0.30 ppm/Cl² compared to the recommended goal of >.20 to <1.0 ppm/Cl² at the entry point to distribution system. The EPA maximum concentration level (MCL) not to be exceeded for chlorine residual is 4.0 ppm. The monthly total coliform and e-coli water sample test results were both negative.

The water recorder at the vault hasn't been working properly. Harland Pease will be looking at it this coming Monday.
